# BOSTON WATER AND SEWER COMMISSION REGULAR MEETING

Wednesday, January 25, 2023

#### I. CALL TO ORDER

A Regular Meeting of the Boston Water and Sewer Commission was called to order at 10:00 A.M. on Wednesday, January 25, 2023, at the office of the Commission, 980 Harrison Avenue, Boston, Massachusetts. Under the provisions of G.L. c. 30A, and per an Act Extending Certain State of Emergency Accommodations, which was signed into law by the Governor of Massachusetts or his designee on July 16, 2022, which suspends certain provisions of the open meeting law, this meeting was conducted remotely. The dial in and meeting identification were publicly noticed.

Present at the meeting were Commissioner Michael J. Woodall and Commissioner Thomas Keady a constituting a quorum for the transaction of business; Messrs. Canavan, Dayib, Hoglund, Hunt, LaMarca, Petruzziello, Piacenza, Rossi, Sullivan, Van Dam, Vitale, and Mses. MA, Mahoney, McSweeney, and Theodat of the Commission Staff. Commissioner Woodall acted as Chairman and Mr. Vitale acted as Secretary. Also present were additional Commission employees and one member of the public.

Upon opening the meeting Mr. Vitale asked Chairman Woodall to give an overview of the format of the meeting. Chairman Woodall informed participants that the meeting was being held virtually and that at the conclusion of the open session the Board would be meeting in Executive Session and would not reconvene in open session following Executive Session.

## **Engineering**

1. Request for Authorization to Award Contract No. 19-308-001, for Water, Sewerage and Drainage Works Improvements in the South End Phase 1. Upon Motion duly made by Chairman Woodall and seconded by Commissioner Keady, Chairman Woodall voted yea, and Commissioner Keady voted yea.

**RESOLVED:** That the Commission is authorized to award Contract No. 19-308-001 for water, sewerage and drainage works improvements in the South End Phase 1 to P. Gioioso and Sons, Inc. in an amount not to exceed \$10,679,336.78; and the Executive Director is authorized execute the necessary contract documents.

2. Request for Authorization to Award Contract No. 19-309-004, Rehabilitation and Replacement of Water, Sewer and Drain Pipes in the City of Boston. Upon Motion duly made by Chairman Woodall and seconded by Commissioner Keady, Chairman Woodall voted yea, and Commissioner Keady voted yea.

**RESOLVED:** That the Commission is authorized to award Contract No. 19-309-004 rehabilitation and replacement of water, sewer and drain pipes in the City of Boston to Umbro and Sons, in an amount not to exceed \$5,629,052.65; and the Executive Director is authorized execute the necessary contract documents.

3. Request for Authorization to Negotiate and Execute Contract No. 22-206-005, Design of the Dorchester Interceptor Relief Sewer. Upon Motion duly made by Chairman Woodall and seconded by Commissioner Keady, Chairman Woodall voted yea, and Commissioner Keady voted yea.

**RESOLVED:** That the Commission is authorized to negotiate Contract No. 22-206-005, to CDM Smith Inc. to provide engineering services in connection with the design of the Dorchester Interceptor Relief Sewer in an amount not to exceed \$2,378,836.00; and the Executive Director is authorized to execute the necessary contract documents.

4. Request for Authorization to Advertise Contract No. 23-309-004, Sewer and Drain Condition Monitoring in the City of Boston. Upon Motion duly made by Chairman Woodall and seconded by Commissioner Keady, Chairman Woodall voted yea, and Commissioner Keady voted yea.

**RESOLVED:** That the Commission is authorized to advertise Contract No. 23-309-004, sewer and drain condition monitoring in the City of Boston.

1. Request for Authorization to Publicly Advertise and Solicit Proposals for the Acquisition and Implementation of a Construction Project Management System. Upon Motion duly made by Chairman Woodall and seconded by Commissioner Keady, Chairman Woodall voted yea, and Commissioner Keady voted yea.

**RESOLVED:** That the Commission is authorized to publicly advertise and solicit proposals for the acquisition and implementation of a construction project management system.

completion of the Executive Session; and further
