BOSTON WATER AND SEWER COMMISSION REGULAR MEETING

Monday, June 28, 2021

I. CALL TO ORDER

A Regular Meeting of the Boston Water and Sewer Commission was called to order at 1:00 P.M. on Monday, June 28, 2021. Under the provisions of G.L. c 30A, and per the Act Extending Certain COVID-19 Measures Adopted During the State of Emergency, which was signed into law by the Governor of the Commonwealth of Massachusetts on June 16, 2021, which suspends certain provisions of the open meeting law until April 22, 2022, this meeting was conducted remotely. The dial in and meeting identification were publicly noticed.

Present at the remote meeting were Commissioner Michael J. Woodall, Commissioner Cathleen Stone, and Commissioner Thomas Keady, constituting a quorum for the transaction of business; Messrs. Canavan, Dwyer, Hunt, Piacenza, Sullivan, Van Dam, Vitale, and Mses. Hickson, Ma, Mahoney, McSweeney, Randolph, DiLoreto Smith, and Theodat of the Commission Staff. Commissioner Woodall acted as Chairman and Mr. Vitale acted as Secretary.

Upon opening of the meeting, Mr. Vitale asked Mrs. DiLoreto Smith, General Counsel, to provide an overview of the format of the meeting. Mrs. DiLoreto Smith informed participants that the meeting was being held virtually and in compliance with the Act Extending Certain COVID-19 Measures Adopted During the State of Emergency extending the suspension of certain provisions of the Open Meeting Law. She further informed participants that the Board would not meet in Executive Session following the open session.

Following this introduction, Mr. Vitale asked Mrs. DiLoreto Smith to provide an update on the Commission's efforts as they relate to the COVID-19 pandemic, including reopening plans, proposals for the future, and potential sources of federal funding, and Mrs. DiLoreto Smith did so.

Next, consideration was given to a draft of the Minutes of the Regular Meeting of the Commission held on May 26, 2021. Upon Motion duly made by Chairman Woodall and seconded by Commissioner Stone, Chairman Woodall voted yea, Commissioner Stone voted yea and Commissioner Keady voted yea.

1. Preliminary Results of the 2020 Disparity Study.

Following an introduction by Hussein Dayib, Director of Organizational Diversity, staff from BBC Research and Consulting presented the preliminary results of their study, whose purpose was to assess whether minority and women owned businesses faced any barriers in contracting.

Ratification of Disbursements for May 17, 2021 through June 14, 2021. Upon Motion duly made by Chairman Woodall and seconded by Commissioner Stone, Chairman Woodall voted yea, Commissioner Stone voted yea, and Commissioner Keady voted yea.
