**Section D**

- As-built drawings of BMP, or BMP design document with written report certifying that the construction of the BMPs was done in accordance with the approved design.
- Calculation of total impervious area of the property and the required volume of storage to meet BWSC requirements.
- Certification by a registered Professional Engineer that the BMP was installed as shown or described in the attached documents and is still functioning as designed. (See Section E)
- Certification by a registered Professional Engineer of the volume of storage captured by the BMP (See Section E)
- BMP Operations and Maintenance (O&M) Plan

**Section E****Applicant's Professional Engineer Certification (if required)**

If you are applying for a BMP credit and your BMP was not installed within the past five years of the date of this application then your BMP must be certified as functioning by a registered professional engineer.
