Re: MWRA Annual Maintenance Program

Dear Mr. Sullivan:

The MWRA's Metropolitan Operations is continuing its FY25 Valve Exercising Program. This maintenance program includes the exercising of main lines, blow offs, and air valves along our pipeline sections. Excavation of paved surfaces will not be necessary for this program.

During the month of **April 2025** MWRA personnel will perform the above referenced maintenance work on various MWRA water mains including MWRA Sections 19, 20, 52, 58, 76, 96, 105, and 106, as well as the Shaft 7C line, Fisher Hill Lines, Walnut Street Line, Warren & Cottage Line. This work may result in discolored water but is not expected to create any pressure losses at the meters listed below. Discolored water may be anticipated for three days after the work is completed.
